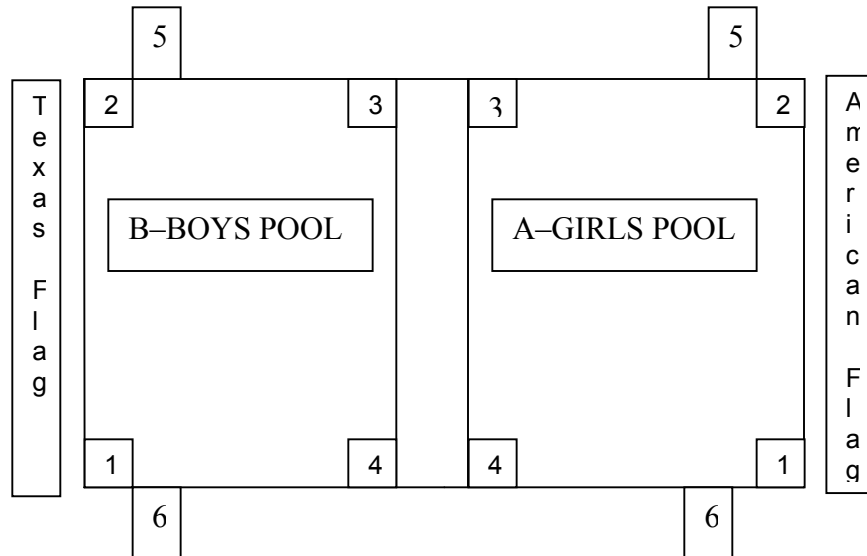

## Stroke/Turn Judge and Runner Positions for All Sessions 1, 2 & 3

### West Side (Diving Well)



### East Side (Entrance) Bleachers

#### **This schedule and noted positions apply to both AM and PM Sessions:**

- Session 1 for 6 & under meet will swim in the Boys pool.
- All judges will use the USA Swimming rules for judging all swimmers for all strokes.
- Positions 1 & 2 are judging for the individual events (IM, Backstroke, Freestyle, Breast Stroke, and Butterfly)
- When judging individual events, Deck Positions 1 & 2 will each judge the four (4) lanes closest to their position.
- Judging will not interchange from the sides to the bulkhead for different individual events.
- Judges will walk the sides for individual events except backstroke deck positions 1 & 2 will be on the bulkhead.
- When judging backstroke 50 yard events, Deck Positions 1 & 2 should stand on the bulkhead to evaluate the backstroke turns only.
- Positions 1, 2, 3, 4 are for judging relay starts and exchanges.
- For relay assignments, stroke judging includes both relay exchanges and stroke requirements at half the length of the pool.
- Runner #5 covers the west side (diving well) of the pool; Runner #6 covers the east side (entrance/bleachers).
- Runners will be responsible for DQ slips moving from judges to the scorer's area.
- All teams should bring 40 DQ slips for each meet session (this means x3). All teams need to bring their own clip boards.
- False starts will be grounds for DQ and noted by the stroke judges when in deck positions 1 & 2. Only exception is on the 50 backstroke when judges are on the bulkhead.
- Scribes for breast stroke and butterfly will be needed for Session 1 for 6 & under and Session 2 AM both boys and girls pools.
